### Crest Audio® CL10 PLUS

The new CL two-way enclosure series features high power ratings with custom components, a sleek look and a unique, snap-in metal grille. The CL10 PLUS is a two-way system featuring tweeter protection, 1.4" diaphragm horn-loaded tweeter, and one high-performance 10" woofer. It is rated at 300 Watts continuous and 1200 Watts peak. This lightweight speaker system is ideal for smaller venues where space is at a premium. Connections include a NL-4 four-pin twist-lock jack and a screw terminal barrier strip. The CL Series is available in black.

## Flying or Mounting the CL Enclosure

**⚠ CAUTION:** Before attempting to suspend this speaker, consult with a certified structural engineer. Speaker can fall from improper suspension, resulting in serious injury and property damage. Do not suspend or mount any other product or device from this enclosure! Use only the correct mating hardware. All associated rigging is the responsibility of others. Maximum enclosure angle 30 degrees.

Failure to follow proper rigging specifications listed in the manual may result in injury or death.

Whenever possible, in addition to the nominal primary mounting method, use a suitable safety chain or wire rope attached to one of the other groups of fly point inserts, and firmly attached to a suitable structural member as indicated by a certified structural engineer.

**CAUTION: ALWAYS USE SAFETY CHAIN.**

We recommend the use of Tread-locker at the insert point bolts, so the bolts cannot vibrate loose. Never transport the cabinet using the array bracket or other mounting brackets as a structural member, while the cabinet is mounted on an array bracket or other mounting bracket and unsupported otherwise, as this may unduly stress the mounting inserts.

**INSPECT RIGGING ANNUALLY.**

This Crest Audio® loudspeaker should be suspended overhead only in accordance with the procedures and limitations specified in the User's Manual and possible manual update notices. This system should be suspended with certified rigging hardware by an authorized rigging professional and in compliance with local, provincial or national suspension ordinances.

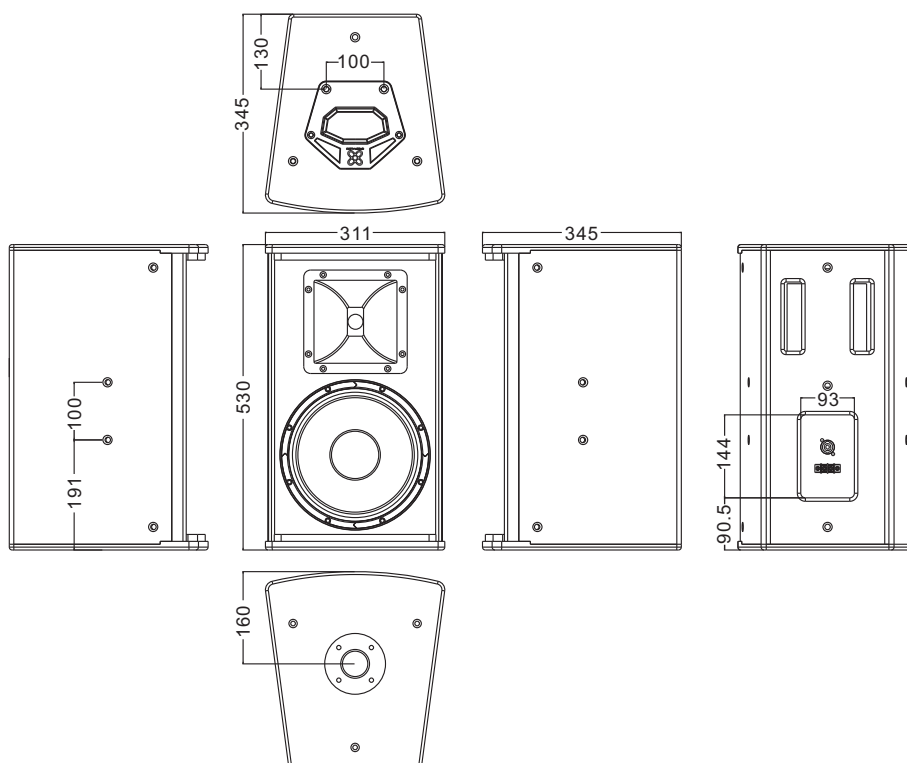

## INSTALLATION

**⚠** Nineteen M8 1.25 mm per thread threaded mounting suspension points (5 top, 3 bottom, 4 each both sides, and 3 rear) are provided. These are plugged with a hex key beveled head bolt.

The nineteen mounting suspension points are for use with forged shoulder machinery eyebolts and should be an M8 size, 1.25 mm per thread, and must conform to at least DIN 580 or ASTM A489, or whatever local, provincial or national suspension ordinances or regulations may additionally require. Eyebolts must be used in groups of 3 or 4, never use just one or two eyebolts to hang the speaker overhead.

## 吊挂或安装CL系列音箱

**注意:** 在试图吊挂该扬声器之前, 请咨询有资质认证的结构工程师。扬声器可能会因吊挂不正确而掉落, 从而会导致严重的人身伤害和财产损失。不要在该产品箱体上吊挂或安装任何其他产品或设备! 只能使用正确配套的五金硬件。所有相关的索具都是他人的责任。音箱最大吊装角度为30度。未能遵循手册中列出的正确索具规范可能会导致受伤或者死亡。

尽可能, 除了标准的主要安装方法外, 还应使用适合的安全链或钢丝绳连接到音箱其他一组吊挂点上, 并按照有资质的结构工程师的指示牢固地连接到合适的结构件上。  
注意: 始终使用安全链。

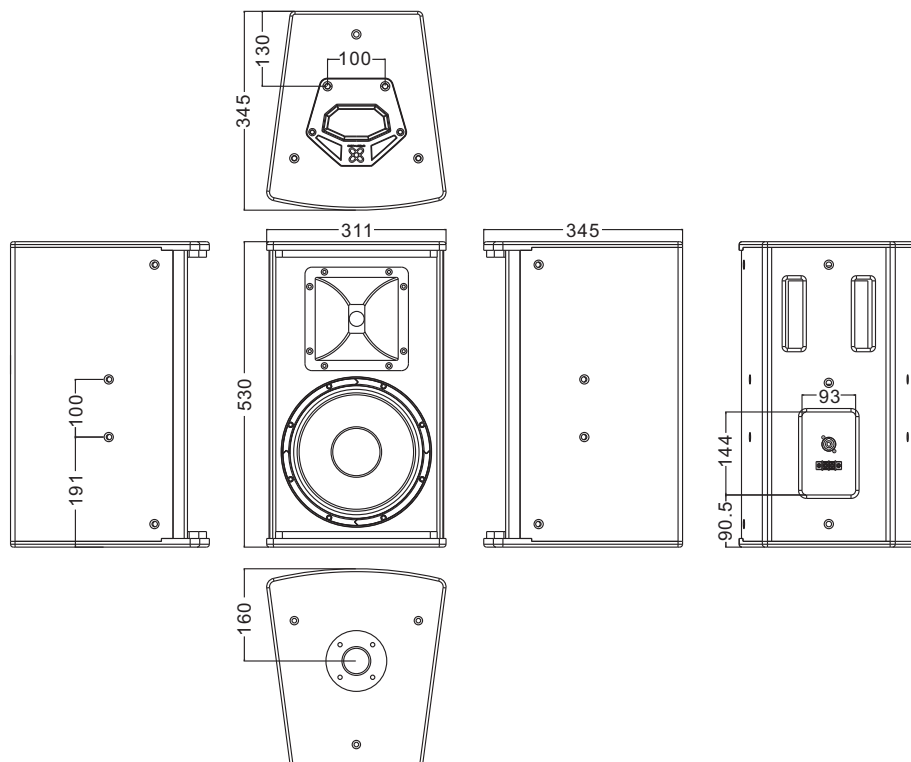
我们建议使用螺纹胶在插入的螺栓处, 防止螺栓松动。在将箱体安装在阵列支架或其他安装支架上且没有其他支撑的状态下, 切勿使用阵列支架或其他安装支架作为结构部件搬运箱体。因为这可能会对安装插入件造成过度的承受压力。每年检查索具。

Crest Audio® 扬声器只能根据产品说明书中规定的步骤及限定的参数和可能的手册更新通知将扬声器悬挂到高于头项位置。该系统应由经过授权的索具专业人士使用经过认证的索具硬件进行悬挂, 并遵守地方, 省或国家的悬挂安装条例。不要过度扭矩硬件。

## 安装

该系统共提供19个1.25 mm螺纹M8尺寸安装吊挂点(顶部5个, 底部3个, 两侧各4个, 背面3个)。这些装入的是六角螺栓。

19个安装悬挂点与锻造肩部机械吊环螺栓一起使用, 应该是M8尺寸, 每根螺纹1.25毫米, 并且必须至少符合DIN 580或ASTM A489, 或任何地方、省或国家悬挂条例或法规的要求。吊环必须以3个或4个为一组来使用, 切勿只用1个或2个吊环螺栓把扬声器挂在头顶上。始终使用适当等级的硬件。
